The focal point of the event is a Young Scholars' conference, with invitations extended to students from diverse institutions. The overarching aim is to encapsulate the essence of World Day of Social Justice, fostering discussions that aim to nurture a fairer and more inclusive society through the exchange of ideas. The history of human civilisation has been plagued with oppression and inequalities. From caste and gender violence to persecution of tribes and communities, history has witnessed numerous forms of injustice. The great leaders of the past are remembered for their consistent efforts to eradicate these forms of inequalities. Lamentably, many of these practices of the past have crept into the present times. Realising the strong presence of injustice in the world, the United Nations has recognised the 20th of February as the World Day of Social Justice to spread awareness about the need for social justice, and encourage efforts to tackle issues such as poverty, inequality, exclusion, and discrimination.

Social justice involves the fair and equitable distribution of resources, opportunities, and privilege within societies. It emphasizes the elimination of discrimination based on factors such as gender, age, race, ethnicity, religion, disability, or socioeconomic status, social disparity. At its core, social justice aims to rectify historical and systemic injustices, ensuring that all individuals have the chance to thrive and fulfill their potential. The celebration of the World Day of Social Justice aims to highlight the importance of addressing social and economic challenges that impact people worldwide
