

- 1. Work shall be done as per latest CPWD specifications 2018 with up to date corrections, slips and direction of Engineer/Architect/AO/Site-in-charge/caretaker etc.
- 2. Water and electricity shall be supplied by the College and recovery @ 1 % for water and 1 % for electricity shall be made from dues of Contractors/Vendors/Firm/Company etc. 10% of cost of work shall be retained as security deposit for the defect liability period (DLP) for one year from the date of actual completion of the work.
- 3. Time allowed to complete the work is one month from date of issue of work order otherwise compensation @1 % (One per cent) of Cost of work per day subject to maximum of 10% of cost of the work shall be recovered from dues/bills of the Contractors/Vendors/ Firm/Company etc.
- 4. TDS for Income Tax & labor cess shall be deducted as per govt. rules from dues/bills of the Contractors/Vendors/Firm/Company etc.
- 5. Rate quoted shall be inclusive of all Taxes including of GST, Octroi, Cartages, loading, unloading etc. Nothing extra is payable. Any changes/revision of Rate in Taxes made by Govt. after award of work shall be adjusted upward or downward, as the case may be.
