

**REPORT**  
**CODE OF CONDUCT AND PROFESSIONAL ETHICS**  
**23rd July 2021**

The IQAC organized a seminar on “**Code of Conduct and Professional Ethics**” on July 23, 2021 in a blended (online+offline) mode. The resource person of the webinar was **Dr. Vikas Gupta, Registrar, University of Delhi.**

The session began with a welcome address by Dr. Shilpa Chaudhary, IQAC Coordinator. In her introductory remarks by Prof. Swati Pal, Principal, JDMC. Dr. Vikas Gupta apprised the audience in detail about the code of conduct expected from teaching and non-teaching staff. The staff should display integrity, devotion to duty, promptness, courtesy and also submit correct declarations. He elaborated on the instances of misconduct. The speaker emphasized the importance of following proper channels of communication.

The speaker also described the code of conduct that is expected specifically from teachers. He said that whoever adopts teaching as a profession assumes the obligation to conduct himself / herself in accordance with the ideal of the profession. A teacher is constantly under the scrutiny of his students and the society at large. Therefore, every teacher should see that there is no incompatibility between his precepts and practice. The national ideals of education which have already been set forth and which he/she should seek to inculcate among students must be his/her own ideals. The profession further requires that the teachers should be calm, patient and communicative by temperament and amiable in disposition. Dr. Gupta discussed various components of the code of conduct towards college, students, non-teaching staff, guardians and authorities.

The Webinar was attended by more than 240 teaching and non-teaching staff of various colleges and departments of University of Delhi. The audience highly appreciated the webinar and expressed their thanks for organizing this extremely useful and relevant session.

The webinar ended with a vote of thanks by the IQAC coordinator.
