Terms & Conditions for Repairing & Strengthening of Existing (15 no.) Dining table at JDMC

- 1. Work shall be done as per latest CPWD up to date Corrections Slips and direction of Engineer/Architect/Site in charge etc.
- 2. Time allowed to complete the work is 15 days from date of issue of work order.
