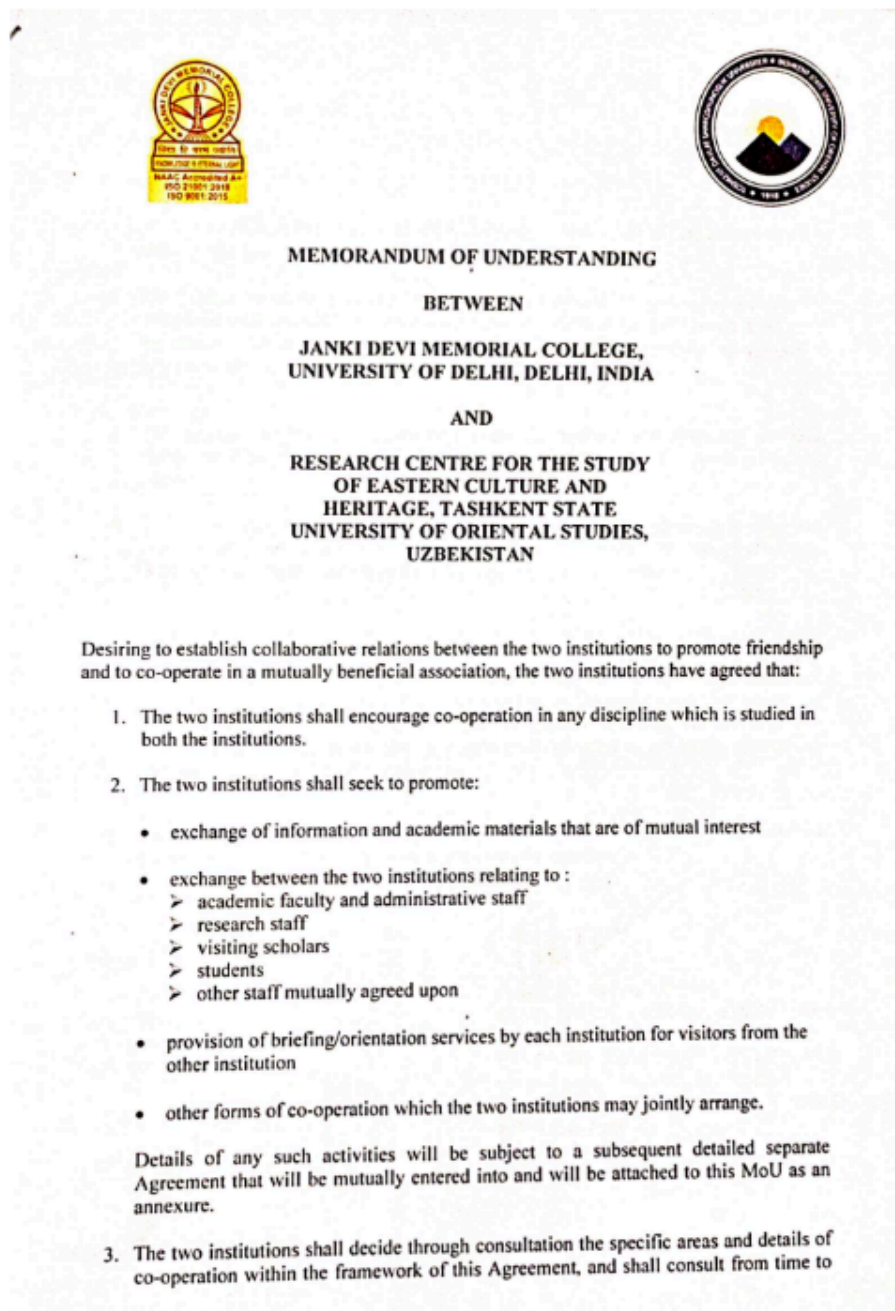

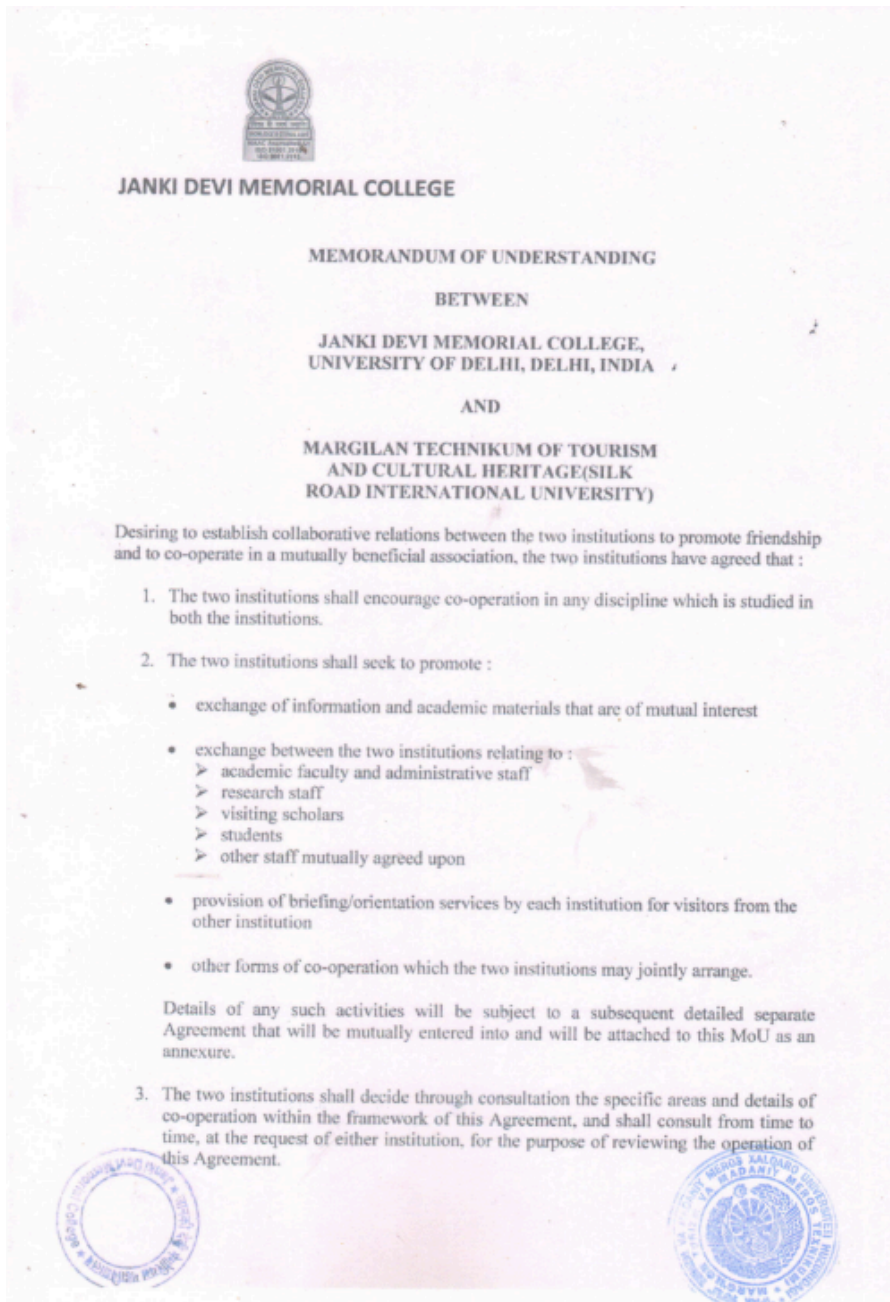

- 4.5 To forge mutually beneficial linkages with its partners through various platforms so as to initiate and assist innovation activities and boost start-ups.
- 4.6 To cultivate the feeling of brotherhood among youths of the two institutes through co-curricular, sports and extracurricular activities.
- 4.7 To encourage cultural exchange and foster the spirit of national integration.

#### 5. Intellectual Property Rights:

Ownership of any intellectual property (including but not limited to confidential information, know-how, patents, copyrights, design rights, rights relating to computer software, and any other industrial or intellectual property rights) developed jointly during the course of this MOU shall be vested in Partner Institutes to this MoU. The Partner institutes shall have the joint right to determine the commercial exploitation and disposition of such intellectual property, and Partner Institutes shall make joint applications for the registration of the same. Before any registration or commercialization of any intellectual property takes place, the Partner institutes agree to reach a separate agreement covering issues such as exploitation rights and revenue sharing. Any publication regarding such intellectual property shall only be possible with the prior written consent of Partner institutes, such consent not to be unreasonably withheld. University of Delhi shall be free to use perpetually the results arising out of the collaborating activities for its own internal teaching, research, educational, clinical and publication purposes without the payment of royalties or other fees to the other parties.

6. The University of Delhi shall facilitate in the process of establishing partnership under this Scheme. It shall oversee the general implementation of the V2Scheme.
7. The Second Party shall submit a report to the University of Delhi within seven days of completion of any activity taken up under V2Scheme.






To Develop a 30-hour add-on course on understanding allergies, types, and management in collaboration with the Department of Environmental Studies (JDMC) and AVANI-The Environmental Club (JDMC) under the aegis of the IQAC center for career opportunities (JDMC). This course will be named as "Allergy Awareness Module".

II. Sharing of resource materials (pre-recorded videos, questionnaires, etc.) by Dr Neeraj Gupta and team to fulfill the requirements of the add-on course.

III. Conducting/ Managing add-on course by the faculty members of JDMC on the virtual platform. Conducting a virtual interactive session once a month with the resource person of the add-on course.

IV. The whole 30-hour module is planned to run over 3 months. Students/teachers need to enroll at the start of the module. No student/any other person will be allowed to join the module in between. Enrollment procedure will be completed by College authorities and the same list of students/teachers along with details of college resource person will be shared (Name, designation, contact numbers, Email ids, State/City of Permanent Residence) with Dr Neeraj Gupta and team (2nd party) before the start of each module.

V. The 30-hour "Allergy Awareness Module" will be conducted in three monthly sections, each section to be completed in consecutive months with 10-hours duration each. In each section, there will be 6 pre-recorded sessions, of 1 hour each, to be conducted by an allocated resource person followed by 15 minutes of assessment. The allocated resource person (for the month) will collect all the queries from the students and email them to Dr Neeraj Gupta and team latest by 25th of respective month. In the last week of the respective month, one 2.5 hours virtual session will be conducted by a specialist (either Dr Neeraj Gupta or his team members), to summarize the previous sessions and solve the queries.



## PARTIES HERE TO AGREE AS FOLLOWS:

### CLAUSE 1 CO-OPERATION

Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

### CLAUSE 2 SCOPE OF THE MOU

Saksham in collaboration with Janki Devi Memorial college attempts to address the above- mentioned challenges through its multi- pronged approach and aims at taking students with visual impairment of the college ahead together with their sighted peers.

#### 2.1 Objectives of the collaboration

1. Facilitate quality education for persons with blindness or low vision.
2. Enable students and staff with blindness to read and write assignment and examinations in mainstream script.
3. Provide books and instructional materials in accessible format to persons with blindness and low vision that can be read with eyes, ears and fingers

#### 2.2 Focus Areas

- 2.2.1. Ensure access of appropriate assistive technology solutions in an affordable manner

As part of the program, a thorough assessment will be conducted to understand the specific needs of each beneficiary, based on which the most suitable assistive device will be made available to them.

To ensure that these devices become affordable and obtainable for the end users, their cost will be subsidized/provided free of cost as per the subsidy schemes/funds available at Saksham.

## 2.2.2 Providing accessible content

The study material (notes and reference material; text books in digital and braille format) of their syllabus will be made available to the students in accessible format which they can read with the help of provided devices.

In addition, books with tactile diagrams will also be made available to the students as per their requirement to aid them in education of subjects like Science, Mathematics, Geography, Economics etc. These books contain embossed tactile diagrams which can be explored by visually challenged students through touch of their fingers, and allow them to understand various diagrams, images and other visual concepts that are highly critical and integral to the learning of these subjects.

## 2.2.3 Membership of Sugamya Pustakalaya

Janki Devi Memorial College will be made member of Sugamya Pustakalaya by paying a membership fee to DFI and through which all the students with visual impairment of the institute will get access to thousands of books available on Sugamya Pustakalaya (an online library of accessible books), and the required content will be made available to them in E-text, audio and braille formats.

## 2.2.4 Trainings and workshops

It has been well documented and researched globally that training is vital for the successful adoption of any assistive technology and accelerate the process of cascading any new concept or program.

- Therefore, Saksham will bundle up devices with the requisite training (duration of the training as per the complexity of the technology/device being provided). This will be given by Assistive technology trainers of Saksham.
- Awareness and sensitization workshops will also be organized for the students, parents, staff members and supporting staff.
- Training and orientation sessions will also be arranged for producing accessible content which will involve digitization of notes, preparing assignments and making images and diagrams accessible.
- Employment Oriented workshops, trainings and courses will be provided regularly for guiding the students and help them set their career goals.

## 2.2.5 Organise Recreational and Sports activities for SBLV

Recreational activities like movie shows of audio described movies will be organized from time to time for students with Blindness and low vision. Adaptive sport activities like Chess competitions with the help of accessible Chess Boards and races using smart cane and tethers can also be organized at the campus.

## 2.2.6 Awareness and Sensitization activities for Non-disabled students and staff members

Many fun activities can be organized to facilitate social inclusion of PWD. Simple day to day activities with blindfolding the sighted students can be organized which will make them realise the challenges of a student with visual impairment and help to sensitize them.

## 2.2.7 Making Built Environment Accessible for PWD

Saksham will help the institute make the necessary adaptations with the existing infrastructure for making the built environment accessible for Persons with Disabilities. This includes putting up braille signboards, tactile markings, installing anti-skid and colour reflecting tapes etc.

## 2.2.8 Provide Need based support to faculty by special educators

Special Educators at Saksham resource Centre can provide support as and when required to the faculty of the college. This would help them to provide necessary support to students with Visual Impairment and low vision in the classroom for their inclusion and education.

## 2.2.9 Organise financial resources

Saksham will make efforts to arrange funds for carrying out the above-mentioned activities. Funds would be raised through leveraging various schemes of the government of India and through CSR/Individual donations. However, the college would contribute financially wherever it is necessary. The financial commitments related to each of the above-mentioned activities will be decided mutually by the first and the second party.

#### Timeline

The project will run for 12 months, that is, September 2022 - August, 2023. While some of the planting work for the JDMC Biodiversity trail will be done in the first year, additional species of shrubs, grasses and climbers will continue to be added gradually as we learn about them and collect them - this bit will take longer, and one can review the work at the end of the first year of work to see how it is progressing. We can't do most of the planting this monsoon as it is right at our doorstep and it takes time to procure native plants as they are readily not available in common nurseries.

This agreement will take effect from 1st September, 2022 and shall be valid for twelve months period till 31st August, 2023 unless sooner terminated, revoked OR modified by mutual written agreement between the signatory parties, and may be extended by mutual written agreement.

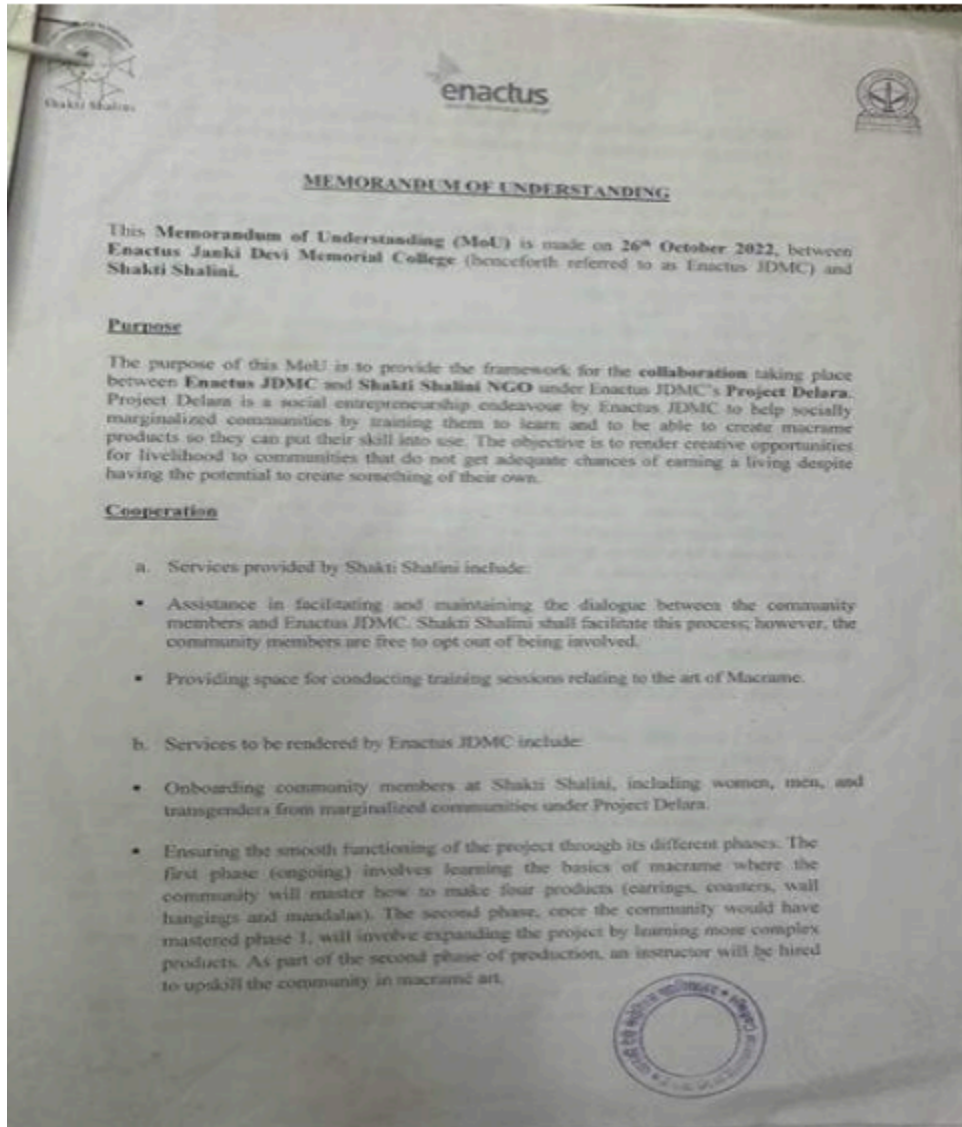

- Conducting skill-building and training sessions relating to the art of macrame by hiring an instructor during the second phase of production (i.e., the expansion).
- Throughout the different phases of the project, the skill-building and training will not be limited to designing and producing but also to purchasing raw materials, maintaining records, marketing, selling, etc. Essentially, train the participants in all aspects that will enable them to design macrame products by themselves, to the extent of becoming self-sufficient and eventually being able to run the business independently.
- The initial investment for the purpose of acquiring raw materials would be made by Enactus JDMC and the subsequent future investments would be made from the 30% of profits earned that would be reinvested in the project.
- Upon completion of production, Enactus JDMC shall facilitate the sale of the products via various platforms, primarily online (Instagram, WhatsApp, Facebook, etc.) and all profits would be divided in the ratio of 70:30 among the community and project, respectively.
- For each product, Enactus JDMC proposes that 70% of the revenue be distributed to the community member who produced it, and the other 30% be reinvested back into the project. This shall be finalized after the agreement of the community members.

## Understanding

It is mutually agreed and understood by and among the partners of this MoU that:

- a. Each partner will work together in a coordinated fashion for the fulfillment of the project purpose.
- b. In no way does this agreement restrict involved partners from participating in similar agreements with other public or private agencies, organizations, and individuals.
- c. This MoU will be effective upon the signature of both partners. The same procedure will be followed for any amendments.
- d. The project's efficiency shall be measured on the basis of its progress which would further determine the future operations of the project.
