

Certificate Course on Development Finance (2020-21)

The add-on course “Certificate course on Development Finance” was offered by the Economics Department, JDMC in Collaboration with the Centre for Financial Accountability (CFA), New Delhi. This course was conducted by the Centre for Financial Accountability.

The Centre for Financial Accountability (CFA) aims to strengthen and improve financial accountability within India. CFA engages in critical analysis, monitoring and critique of the role of financial institutions – national and international, and their impact on development, human rights and the environment, amongst other areas.

The Certificate Course on Development Finance introduces the students to the financial institutions and their role and responsibilities in development. It would help students to understand the linkages between financial institutions, policies and socio-economic development and how different financial institutions shape the development process of the country.

The understanding of finance, financial institutions and their influence would help students to have a better understanding on what influences policies, its push and pulls and how finance plays a prominent role in subjects they study, whether it is education, development, social policy, humanities or technology.

The course is a combination of lectures, seminars, group discussions, assignment and evaluation.

Topics Covered:

1. Introduction to Development Finance, 2. Sources of Finance and Financial Instruments, 3. Development Financial Institutions in India and Role of Public Banking, 4. Public Banking and the Assault on PSB, 5. Regulator Institutions and Mechanisms, 6. Understanding International Financial Institutions, 7. How do IFI influence Policy, 9. Accountability Mechanism and How to Monitor Projects, and 10. How to effectively use national and international mechanisms to effectively bring social policy influence.
