

An MoU for Knowledge sharing between Academy and NGO

MEMORANDUM OF UNDERSTANDING

Between

Janki Devi Memorial College located on Sir Ganga Ram Hospital Marg, New Delhi, Delhi 110060

And

CHINTAN Environmental Research and Action Group, hereafter referred to as CHINTAN, a registered organization having its registered office address at 238, Sidhartha Enclave, New Delhi-110014.

FOR DEVELOPMENT OF ACADEMIC COOPERATION

Chintan Environmental Research and Action Group is a non-profit, non-governmental organization established as a means of addressing issues of sustainable consumption and environmental and social justice. Chintan is authorized by Delhi Pollution Control Committee for collection, segregation and storage (without dismantling and recycling).

The general objective of this Memorandum of Understanding (MoU) is to establish a mutually beneficial relationship built on academic and scientific cooperation with the ultimate objective of knowledge sharing. It also ensures proper collection and disposal of e-waste from Janki Devi Memorial College by Chintan. It will help college to be certified that their e-waste is being recycled through proper authorized channel. The revenue generated from e-waste will be used for educating wastepickers children in Chintan's No Child in Trash program. Currently there are 24 learning Centre of Chintan in Delhi and NCR area.

The signatory institutions agree to take up the responsibility and provide opportunity, as appropriate, for the following activities towards the completion of the objective of this MoU.

- Janki Devi Memorial College would nominate one person with whom Chintan staff can co-ordinate regarding E-waste collection and other information.


- Concerned person from college will inform Chintan staff about pickup of E-waste, once the bin is fill and at least one day in advance.
- CHINTAN will be responsible for collecting e-waste from the premises of the college.
- The e-waste collected will be taken to our collection center from where it will eventually go to the authorized recyclers.
- CHINTAN should be informed two days prior the pick up along with the approximate quantity of waste so that a pick up vehicle can be arranged accordingly.
- CHINTAN will provide certificate to the college ensuring that their e-waste is recycled through proper authorized channels.


This agreement will take effect from the date of its signing and shall be valid for an unlimited period from the date unless sooner terminated, revoked OR modified by mutual written agreement between the signatory parties, and may be extended by mutual written agreement.

Either party may terminate the agreement at any time during the term by the provision of three months written notice to the other party.


