Authors are requested to prepare their abstract and paper submissions and send a soft copy through e-mail at internationalconferencecom@jdm.du.ac.in. The authors are requested to follow the following guidelines -

- Every paper must be accompanied by a cover page, which should include the title of the paper, name(s) of the author(s) and their affiliations, resident country and the complete postal and e-mail addresses and telephone numbers of the authors,
- The recommended length of an abstract is 150 to 250 words along with 5-6 keywords. The maximum length of the paper should be 3500 words, inclusive of abstracts, all notes, references, tables, and appendices.
- Papers should be prepared and submitted in text format (MS-Word) following U.K. spellings, using Times New Roman font of 12 sizes, and A4 format with 1.5 line spacing. The same file shall be submitted in PDF format as well.
- Referencing style: Authors are requested to follow the APA (American Psychological Association) style of referencing.

Selected candidates will be informed through mail. The decision of the review committee regarding the selection of the papers will be final and binding.
