OBSERVATIONS

OBSERVATIONS

A fairly large proportion of 92% students agreed that the course helped them apply generally accepted accounting principles while recording financial transactions and preparing financial statements. Majority students recognized that the course enabled them to demonstrate accounting process using computerized accounting system. More than 85% students concurred that they were able to measure business income and evaluate the impact of depreciation and inventories on business income using relevant accounting standards. Additionally, most of the students (> 90%) affirmed that the course has equipped them to prepare financial statements of sole proprietor firms, NPOs, as well as enabled them to prepare the accounts of Inland branches, Departments and Leases. Approximately 90% students had more than 50% attendance in this course.

ACTION TO BE TAKEN REPORT

For the students showing positive response during the classes, extra practice questions will be given to make them think analytically and critically. Practical Case studies will be discussed to give them an insight into the practical world. Special Doubt sessions will be taken and

discussion of last 10 years question papers will be done specifically for weaker students. Action Taken Report:

It is observed that a majority of the students (over 70-75%) have responded positively to all the questions related to the understanding of concepts and topics covered in different units of the syllabus of Business Organization and Management. For students showing positive responses during the classes, they were given a real-life example to relate to the study to solve economic problems, assignments given to the students to check their knowledge & skills and open discussions on some selective topics were held in class to make them think analytically and critically. For the section of students who found the paper difficult to understand and grasp the concepts, doubts were taken to help them understand better, chapters were broken down into simpler units and were explained step wise with relatively simple questions, and they were advised to refer to past papers for practice and in future extra practice questions will be given to such students for more practice. A good proportion of students (67%) had over 78.6% of attendance and others were reminded intermittently to attend the lectures on a regular basis to ensure a better understanding of the concepts covered in classes.

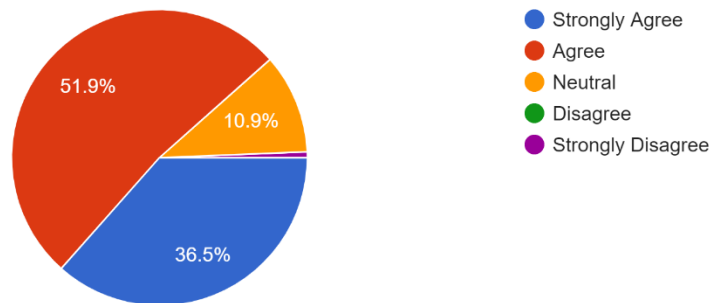

Approximately 95% of the students had attended 67% or more classes for this course.

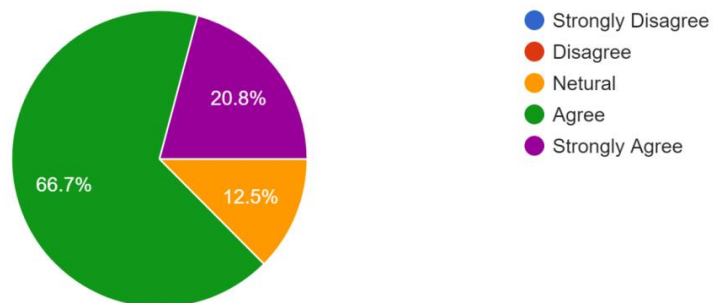

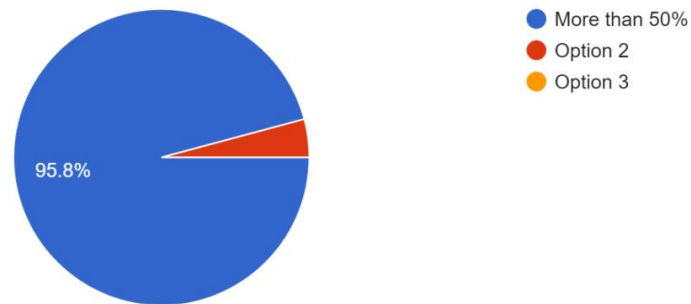

It is observed that the most number of students responded around 95% of respondents attended the classes. Action Taken Report

There has been a favorable response from the majority of the students towards the subject. About 96.9% of the students agreed that the course has helped them understand the basic concepts in the law of income tax and determine the residential status of different persons.

About 95.2% students are able to Identify the five heads in which income is categorised and compute income under the heads 'Salaries' and 'Income from House Property'.

79% of the students are able to compute income under the heading ' Profits and gains of business or profession', 'Capital gains' and 'Income from other sources'. 12.5% are, however, neutral to this.

87% of the students are able to understand clubbing provisions, aggregate income after set-off and carry forward of losses, and deductions allowed under the Income Tax Act; and further to compute taxable income and tax liability of individuals and firms.

96.7% of the students have developed the ability to file online returns of income through this course.

While 45.2% students report more than 67% attendance, 50% report between 50 to 67%.

In order to promote further understanding amongst the students on various aspects of the course, emphasis is given on real life examples and cases and opportunities are provided for group discussions on legal implications of taxes.

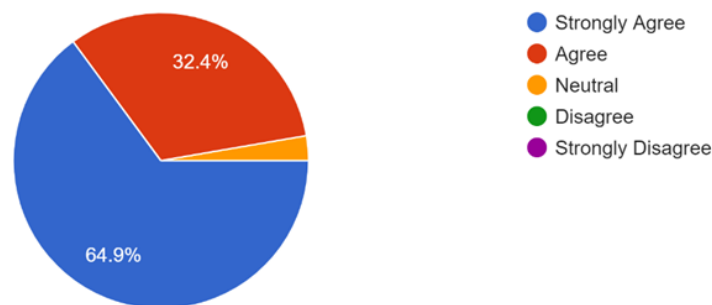

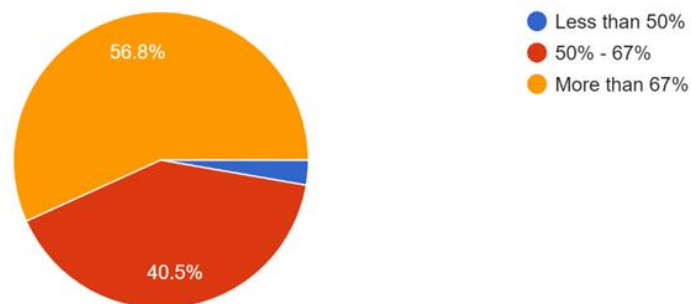

CAPM and portfolio analysis helped students to evaluate the portfolio construction and its effectiveness. Practical cases will be taken to provide a real life example of portfolio management. Special remedial classes will be organized to clarify the concepts of portfolio management.

Action Taken Report: -

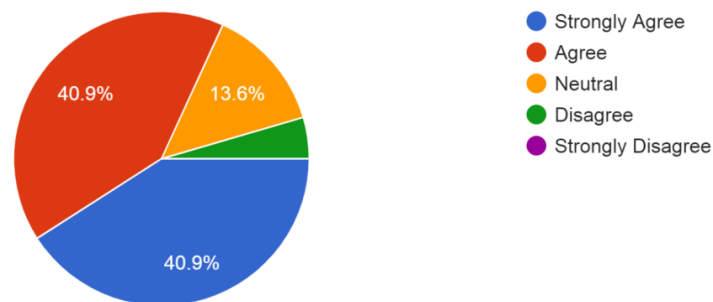
