OBSERVATIONS: Based on the provided responses, it is noted that approximately 92-95% of students either strongly agreed or agreed that this course significantly contributed to their comprehension of child development as a field, including the concept of prenatal development. Additionally, more than 98% of students expressed agreement that the course equipped them with a foundational understanding of data collection techniques, elucidating the scope and utility of the subject. More than 95% of students grasped the multidisciplinary nature of the course. Furthermore, it was observed that 82.7% of students maintained attendance levels of 50% and above (50% students maintained attendance level of 67% and above).

ACTION PLAN REPORT:

Efforts will be directed towards making classes more captivating and engaging, incorporating audio-visual aids and group discussions, to boost overall class attendance.



ACTION TO BE TAKEN REPORT:



Additionally, around 97% of students reported that the course provided opportunities to apply theoretical knowledge in practical settings. To address the concerns reflected in a few of the responses, the relevant topics will be covered in remedial classes.



Based on the responses, it was observed that approximately 94% of students strongly agreed or agreed that they gained an understanding of the concept and importance of early identification and early intervention, as well as the issues, challenges, and services available for children with disabilities. The majority of responses indicated that the course helped them understand various assessment tools for children with disabilities. Around 94% of students reported that the course provided opportunities to apply their theoretical knowledge in practice—for example, by preparing checklists for early detection and interviewing caregivers providing services to individuals with disabilities. It was also noted that 70.6% of students had an attendance rate of 67% or higher, and no student had an attendance rate below 50%.

To address the concerns reflected in a few of the responses, the relevant topics will be revisited in remedial classes.


