12. To report the developments regarding Physical Education Department and steps taken thereof.

Principal apprised that initially the University, on receiving our Roster with the Physical Education posts (01 vacant and 01 filled), advised us to remove the vacant post and also to show the existing post as DPE. The facts are:

- Dr. Mukesh Sagar was appointed as Director of Physical Education (DPE) and retired as Associate Professor (after all DPE posts were regularized as teaching post as per EC Resolution No. EC Resolution No. 127 dated 10.11.1990).
- Dr. Abha Jain was appointed as Assistant Professor in Physical Education. We retained her in the Roster and removed the post of Dr. Mukesh Sagar from the Roster.
- The advertisement for teaching posts was released without the vacant Physical Education post.

- Later it was observed that on some colleges had advertised the post of Physical Education. The college sent letter no. 34 dated 29th May, 2017 to the Dean of Colleges, University of Delhi with the request to allow the College to advertise the post of Physical Education through a corrigendum.

The Governing Body agreed that the final Roster must contain both vacant as well as filled up Physical Education posts and that the revised Roster be sent to the University.




