8. To apprise about the Grievance Redressal case

The Principal apprised the Governing Body about the Grievance Redressal case related to Dr. Subhra Dey of the Dept. of History. She narrated the history of Dr. Dey's repeated irregularity in taking classes etc. over the last decade, her long absences, her harassment of students, her maligning the image of the College etc.

The Principal then spoke about the complaint made by the students of B.A. (Prog) in the last academic session vis a vis Dr. Dey's irregularity and the Apex Grievance Committee that met on February 06, 2017 to discuss it. Dr. Dey was absent. In the meeting (minutes attached), the Committee contemplated disciplinary action against Dr. Dey. However, she proceeded on medical leave and by the time she returned, it was semester end. The Apex Grievance Committee met again on May 19, 2017 and decided that since the College reopened the case would be taken up in the presence of the Chairman. Governing Body. The College reopended on 20th May, 2017 and soon after, NAAC sent its dates (28 and 29 August) and a Grievance Committee had to go abroad urgently as well as the new Chairman of the Governing Body had to be decided. Hence the case got deferred. Meanwhile, Dr. Dey applied for the post of Registrar in Central University of Gujarat. She asked for an NOC which also needed an endorsement that "no disciplinary / vigilance case has ever been held or contemplated or is pending against the applicant". Dr. Pal issued the NOC but with the correction that "There is pending / contemplated disciplinary action against the applicant as per the Apex Grievance Redressal Committee". Legal advice was also taken to corroborate this action. Dr. Pal received a letter from the Registrar, Central University of Gujarat (copy attached) seeking a clarification to which she replied that the matter was in process (copy attached). So. Dr. Pal wanted the Governing Body to advise as to what the next step should be; the fact being that with the forthcoming NAAC Peer Team visit, it would be very difficult to fit in a grievance case at short notice. Prof. Saha and Prof. Chakraborty advised that no hasty action should be taken; that right now the focus should be on the NAAC Peer Team visit and that Dr. Pal could put the case to the Dean (Legal), University of Delhi, for further action.
