



The Principal informed that since verbal permission had been granted for the appointment of the adhoc teachers till the end of the term, she had given the letters of appointment for the same (after a day's break) to all adhoc teachers.

The GB discussed the issue in the light of the letter received from the University of Delhi dated 28th August 2019 and felt that though the letters had been issued, the appointment of the adhoc teachers after their four month appointment since the beginning of the term, would be kept in abeyance till further clarifications in writing is received from the University of Delhi. This included the salaries of the adhoc teachers; they could be paid till the date on which the four month period ended and the rest of the salary released immediately if the University of Delhi gave a written clarification that the appointments adhoc teachers could be renewed.
