The Governing Body with reference to the letter No.CS-I/(111)/Misc./(TS)/JDMC/34/2017/285 dated 11.01.2018 addressed to the Chairman received from the University, scrutinize all correspondence and documents related to Dr. Shubhra Dey and concluded the following:

1. That Dr. Dey notified about her leave on every instance that the Apex Grievance Redressal Committee met, only a short while prior to the meeting. Thus making it clear that despite repeated efforts on the part of the College to give her an opportunity to redress grievances, she chose not to do so.
2. That Dr. Dey has been informed about the nature of the grievances via email and the reason why the complaint letter was withheld from her was to protect the interests of the students who expressed their anxiety at the revelation of their names.
3. That Dr. Dey's allegations and attempt to prove that the Principal was harassing her were baseless and documents provided by Dr. Dey were suspect.
4. That the Apex Grievance Redressal Committee had in any case, resolved the issue by keeping matters in abeyance till she rejoined and decided to open the case only if necessary.
5. The the College had been very fair in its treatment of Dr. Dey and had not prevented her from applying but that it would have been false to withhold information from the University at the time of issuing NOC.
