
Minutes of the Governing Body meeting held on Tuesday, 30<sup>th</sup> July, 2019 at 3:00 p.m. in the Principal's Room.

It was decided that Chanchal would remain on child care leave for next four months i.e. from August to November, 2019. It was recommended that the Department of Political Science could appoint an Adhoc teacher as per the existing panel (i.e. on the basis of last approved 200 point roster).</p> <p>In addition, the Governing Body also decided that Sudha Upadhyaya (Associate Professor, Department of Hindi) would remain on medical leave for next one month or till full recovery, whichever is later.
