3. Structure Audit Report of C-Block. Teaching Staff Quarters

1985

The Structure Audit Report of C-Block Teachers Staff Quarters was placed before the Governing Body. As per the final recommendations of the Report:

- 1) The structure has lived its life completely
- That repairing of the structure is not feasible financially and practically hence the total structure to be demolished and again reconstructed with latest specification and design.
- 3) It is recommended that the building should be got vacated immediately.

The Governing Body advised the Principal to immediately inform the residents about the Audit Report as the safety of residents cannot be compromised. The Principal informed that she would do so after informing the Chairman of the Trust and receiving instructions from him since the Trust was the legal authority of the housing on campus.

Provident Fund issues

1986

The Governing Body was informed that the college had a deficit of One Crore Nine Lakhs Thirty two thousand One hundred and seven rupees till the financial year 2019-2020. This deficit was after minusing the surplus amount (Rs. 7,12,815/-) accrued till the financial year 2014-15. The deficit was as a result of the lowering of the bank rate of interest as compared to the rate of interest declared by the Government from the financial year 2015-2016 onwards.

The Governing Body suggested that the Accounts office could try and find out if there were corpus funds of the college that could be used to meet the deficit. They also recommended that from the financial year 2020-2021, the college should pay only the bank rate of interest so that no more deficit is created. The Principal informed the Governing Body about the 2012 University Grants Commission's letter which allowed institutions to lower the rate of interest as against the declared rate of interest.
