1. The Parties are agreeing to partner under V2Scheme for the purpose of enhancing the mutual growth and development of each other.
2. The academic bonding is based on the principle of mutual respect, cooperation and sharing between the two parties as equal partners.
3. The Second Party shall extend its academic resources and facilities available for the V2Scheme to the Third Party with an aim to be catalyst for the faster growth of the latter. The Third Party shall share its academic resources with the Second Party to the extent possible, on a collaborative basis in the fields of academics, education and research.

- 4.6 To cultivate the feeling of brotherhood among youths of the two institutes through co-curricular, sports and extracurricular activities.
- 4.7 To encourage cultural exchange and foster the spirit of national integration.

5. Intellectual Property Rights:

Ownership of any intellectual property (including but not limited to confidential information, know-how, patents, copyrights, design rights, rights relating to computer software, and any other industrial or intellectual property rights) developed jointly during the course of this MOU shall be vested in Partner Institutes to this MoU. The Partner institutes shall have the joint right to determine the commercial exploitation and disposition of such intellectual property, and Partner Institutes shall make joint applications for the registration of the same. Before any registration or commercialization of any intellectual property takes place, the Partner institutes agree to reach a separate agreement covering issues such as exploitation rights and revenue sharing. Any publication regarding such intellectual property shall only be possible with the prior written consent of Partner institutes, such consent not to be unreasonably withheld. University of Delhi shall be free to use perpetually the results arising out of the collaborating activities for its own internal teaching, research, educational, clinical and publication purposes without the payment of royalties or other fees to the other parties.

(JDNC and BITS Pilani herein referred to individually as "Party" and collectively as the "Parties").


Whereas:

1. Preamble

- 1.1 This Memorandum of Understanding (MoU) is intended to promote co-operation, discussions and positive academic relations between BITS Pilani and JDNC to their mutual benefit.
- 1.2 Opportunities may be sought for the collaborative R&D projects, exchange of academic staff, research scholars for collaboration on joint research projects or such other activities as mutually agreed from time to time, and also to generate external funding for such mutually agreed activities
- 1.3 Nothing in this MoU is intended to be legally binding or shall be construed as creating any legally enforceable rights or obligations between the Parties with the exception only of the provisions in clauses 4, 5, 6, 7, and 8 which are legally binding. This MoU is therefore a statement of intent which sets forth the general basis upon which the Parties wish to proceed;

no contract will arise as to the subject matter hereof (notwithstanding the four legally binding clauses referred to above) unless and until an agreement regarding each or any objective is negotiated, approved, executed and delivered by the Parties.

1.4 The purpose of this MoU is to enable BITS Pilani and JDMC to pursue the Objectives by undertaking the Tasks, all as set out below.

The Parties agree as follows:

2. Objectives

2.1 Both the institutions agree to cooperate in an effort to expand opportunities for further development of research and other academic activities. Such cooperation will include the following activities:

- (vii) Activities related to entrepreneurship, incubation and skill development
- (viii) BITS to function as mentoring institution for JDMC in the field of incubation and entrepreneurship
- (ix) Exchange activities related to TLC
- (x) Other exchange activities to which both institutions identify and agree in writing


3. Tasks for each Party

3.1 Each Party Agrees to:

- 3.1.1 maintain regular and reasonable contact with the other Party, informing the other Party of any relevant changes or developments in relation to this MoU;
- 3.1.2 review of this MoU falls on every fifth year, providing the other party with relevant information and statistics in relation to the objectives, and by mutual agreement in writing, introduce any amendments as may be agreed, and
- 3.1.3 nominate a faculty member/a member of staff to be responsible for overseeing the implementation of this MoU.

4. Costs

1. The Parties agree that each shall bear its own costs in connection with, or for any work under, this MoU, save and except as agreed in writing between the Parties. For the avoidance of doubt, each Party shall (unless otherwise agreed) meet the travel, accommodation and subsistence costs of their own staff involved in visits to the other Party

2. Activities under this MoU will be finalized on yearly basis depending upon resources available for a particular year or generated for the specific purpose following approved/ acceptable norms as applicable to either of parties.
3. This MoU places no financial obligations or supplementary commitments on either party.
4. Financial arrangements for each specific project agreed under this MoU, will be decided mutually on a case-to-case basis and brought on record in each case after due approval from the competent authorities from the Parties.
5. In any of the projects, wherever financial aspects are involved, amount, payment conditions, etc. would be spelt out clearly by the Parties and will be recorded in the definitive agreement, before starting a project.

5. Confidentiality

- 5.1 The both sides shall maintain confidential as a confidential information of the other party, the information which is announced explicitly as confidential upon its disclosure, among the information disclosed by the other party in any duties under this memorandum, and shall not, without the prior written permission of the other Party, disclose to any other institution or organization or other third party any confidential information it acquires from the other Party in connection with this MoU, unless such information:
 - 5.1.1 is already in, or subsequently enters, the public domain (other than as a result of its disclosure by the receiving Party in breach of this clause 5), or
 - 5.1.2 is required to be disclosed by law or any legal or regulatory authority, or
 - 5.1.3 is already known to the receiving Party before the acquisition from the other Party (without being subject to any obligations of confidentiality to the other Party), or
 - 5.1.4 is obtained from a third party in circumstances where no obligation of confidentiality is owed to the other Party in respect of such information.
- 5.2 The obligations of the Parties under this clause 5 shall continue for five years following the expiry or termination of this MoU.

6. Data Protection Compliance

The Parties agree to adhere to the Digital Personal Data Protection Act, 2023 (DPDPA) of India and any relevant foreign data protection laws. This includes ensuring transparent data processing, obtaining necessary consents, and safeguarding personal information

7. Intellectual Property

- 7.1 Any intellectual property rights owned by a Party before the Commencement Date (as defined in clause 9) and during the term of this MoU will remain the property of that Party. Nothing contained in this MoU will affect the absolute ownership rights of either Party in such Party's intellectual property rights. For the avoidance of doubt, no licenses are granted under this MoU.

- 7.2 In the event that either Party wishes to use the name and/or logo of the other Party for any purposes, including without limitation for the purposes of marketing or recruitment, such Party shall obtain the written consent of the other Party in advance of such use and (if such consent is given, at the discretion of the other Party) shall comply strictly with all of the other Party's directions from time to time as to the manner of such use.
- 7.3 Neither of the Parties shall publish any marketing material relating to this MoU without the prior written consent of the other Party, and the Parties agree that the wording for any such marketing materials shall be agreed jointly between the Parties prior to its use.
- 7.4 In case of generation of Intellectual property (Patents) during execution of the Joint Research Project under this agreement (if any), the ownership of the said Patents will be shared jointly. The sharing of royalty will be based on actual contribution of the parties, which will be decided mutually as per actual work done by the parties. The cost of filing/maintenance of such IP will be borne equally by the parties.

8. Effective Term And Alterations To The MoU:

8.1 This MoU will become effective upon the date of its signature and will be valid for a period of 05 years, after which it may be renewed for the same period or any mutually agreed period, subject to the communication and delivery of the intention to do so by one of the parties, by a minimum of 60 days before the end of the term date of this agreement. The parties may extend the term as mutually agreed to, in writing. This MoU may be terminated by either Party by giving a written notice of sixty (60) days to the other Party hereto.

This MoU may be terminated by the Party if the other Party

- (a) breaches the terms and conditions of this MoU, where such breach remains uncured within 15 days from the receipt of notice from the non-defaulting party
- (b) violates and breaches the confidentiality and Intellectual Property terms as set out in this MoU.

Notwithstanding the termination of this MoU, the provisions of this MoU, the nature of which should reasonably require the survival thereof shall survive the termination of this MoU.

8.2 Modifications of and amendments to this Agreement shall be effective only if made in writing and signed by duly authorized representatives of the Parties.

8.3 In the event of termination, both universities will take all necessary measures to avoid any prejudice to themselves or others, and all ongoing actions will be implemented until their conclusion.

9. Representations and Warranties:

Both Parties hereby represents and warrants that:

- a. It has all requisite power and authority to execute, deliver, and perform its obligations under this MoU and has been fully authorized by all requisite coactions to do so.
- b. It has all necessary statutory and regulatory permissions, approvals, and permits for the running and operation of its Institute.

No Party shall be held responsible for non-fulfilment of their respective responsibilities under this MoU due to the exigency of one or more of the force majeure events such as but not limited to acts of god, war, flood, earthquakes, strikes not confined to the premises of the Party, lockouts beyond the control of the Party claiming force majeure, epidemics, riots, civil commotions, etc., provided on the occurrence and cessation of any such event the Parties shall consult with each other on modalities of further execution of this MoU thereby shall give notice in writing to the other party/parties within thirty 15 days of such occurrence or cessation. If the force majeure conditions continue beyond three (3) months, the Parties shall decide the future course of action jointly.

Any notice given as provided by this clause shall be deemed received by the party to whom it is addressed when: (a) in the case of any notice delivered by hand, when so delivered and acknowledged by the recipient as such; (b) if sent by pre-paid post on the third clear day after the date of posting; (c) if sent by electronic mail, twenty-four (24) hours after the electronic mail is sent.

12. General

12.1 No person who is not party to this MoU shall have any right to enforce any terms of this MoU.

12.2 The Parties agree to use all reasonable endeavours to settle any disputes through negotiation by the respective senior management of each Party.

12.3 The Parties will use their best efforts to settle all matters in dispute amicably. All disputes and differences of any kind related to this MoU shall be jointly settled between Principal, JDMC, and Director, BITS Pilani. The interpretation and enforceability of this MoU shall be determined according to the laws of India. This MoU shall be governed by the laws of India.

The arbitration award of the arbitrator shall be final and binding on the parties and shall be enforceable in accordance with its terms. The arbitrator shall state the reasons for their findings in writing. All fees and expenses of the arbitrator shall be borne equally by the parties unless the arbitral tribunal decides otherwise.
- 12.5 Disclaimer: Nothing shall diminish the full autonomy of either party nor will any constraints or financial obligations be imposed by either party upon the other in carrying out this MoU.
- 12.6 The parties agree that this MoU is not binding and will act only as an interim understanding until further Agreements are reached for the separate activities identified within this MoU.
- 12.7 The relationship of the Parties under this MoU shall be non-exclusive to the research scope and deliverables and both Parties are free to pursue other agreements or collaborations of any kind.
- 12.8 Compliance: Both Parties agree not to do anything contrary to law or which would be treated as a corrupt practice under Indian or Foreign law.
- 12.9 Assignment: Save as otherwise expressly provided under this MoU, all rights and obligations hereunder are personal to the Parties hereto and may not be assigned at law or in equity without the prior written consent of the other Party.
- 12.10 Entire Agreement: This MoU sets forth the entire understanding of the Parties with respect to the subject matter hereof and supersedes all prior Agreements between them relating thereto.
- 12.11 Relationship of Parties: Nothing in this MoU shall be deemed to constitute a partnership between the Parties or constitute either Party the agent of the other for any purpose.


14.2 Subject to clauses 8 & 14.1, this MoU shall be in effect for five years from the Date of Commencement. This period may be extended by written consent of both Parties.





2.2. **Rekhi Foundation** may supplement the teaching in the "**Rekhi Centre of Excellence for the Science of Happiness**" from time to time by providing expert staff from its team at the request of the **Janki Devi Memorial College**.

ARTICLE 3: PROMOTION

JDMC Kitchen Garden

JDMC kitchen garden will consist of roughly 600 sq ft of growing space in which AVANI students can get involved to observe, work on and harvest the produce over a period of 6-8 weeks.

Consultant

- Site analysis & designing the garden
- Making a list and getting of plants and quantity of seeds required according to the seasons and the needs of the college.
- Facilitating and guiding college *maalis* and volunteer students for creating beds and planting vegetables (annuals and perennials) according to the design.
- Making and sharing daily maintenance tasks with *maalis* and volunteer students.

JDMC

The college's role in the kitchen garden will be the following:

- Allocating a space for the garden with protection from animals.
- Allocating the required resources (*maali*, watering arrangements) etc. and tools whenever required.
- The daily tasks of watering, weeding and, at a later stage, harvesting.
- Coordinating with volunteer students and organizing a rooster for them to be able to attend the maintenance/knowledge sharing sessions.




The Second and Third parties shall be jointly referred to as 'Partner institutes' and all the three parties shall be jointly referred to as 'Parties'.

2. The academic bonding is based on the principle of mutual respect, cooperation and sharing between the two parties as equal partners.







4.2. The teachers and researchers of the both the Partner institutes may be engaged in Joint research activities and be co-investigators in the research programmes submitted to funding agencies.


4.3. Joint research publication by teachers/ researchers of the Partner institutes shall be encouraged.

4.7 To encourage cultural exchange and foster the spirit of national integration.







5. Intellectual Property Rights:

6. The University of Delhi shall facilitate in the process of establishing partnership under this Scheme. It shall oversee the general implementation of the V2Scheme.


7. The Second Party shall submit a report to the University of Delhi within seven days of completion of any activity taken up under V2Scheme.



CLAUSE 1 CO-OPERATION

Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

CLAUSE 2 SCOPE OF THE MOU

Saksham in collaboration with Janki Devi Memorial college attempts to address the above-mentioned challenges through its multi- pronged approach and aims at taking students with visual impairment of the college ahead together with their sighted peers.

2.1 Objectives of the collaboration

1. Facilitate quality education for persons with blindness or low vision.
2. Enable students and staff with blindness to read and write assignment and examinations in mainstream script.
3. Provide books and instructional materials in accessible format to persons with blindness and low vision that can be read with eyes, ears and fingers

2.2 Focus Areas

- 2.2.1. Ensure access of appropriate assistive technology solutions in an affordable manner

As part of the program, a thorough assessment will be conducted to understand the specific needs of each beneficiary, based on which the most suitable assistive device will be made available to them.

The range of assistive devices which have been shortlisted for this intervention include:

To ensure that these devices become affordable and obtainable for the end users, their cost will be subsidized/provided free of cost as per the subsidy schemes/funds available at Saksham.

2.2.2 Providing accessible content

The study material (notes and reference material; text books in digital and braille format) of their syllabus will be made available to the students in accessible format which they can read with the help of provided devices.

In addition, books with tactile diagrams will also be made available to the students as per their requirement to aid them in education of subjects like Science, Mathematics, Geography, Economics etc. These books contain embossed tactile diagrams which can be explored by visually challenged students through touch of their fingers, and allow them to understand various diagrams, images and other visual concepts that are highly critical and integral to the learning of these subjects.

2.2.3 Membership of Sugamya Pustakalaya

Janki Devi Memorial College will be made member of Sugamya Pustakalaya by paying a membership fee to DFI and through which all the students with visual impairment of the institute will get access to thousands of books available on Sugamya Pustakalaya (an online library of accessible books), and the required content will be made available to them in E-text, audio and braille formats.

2.2.4 Trainings and workshops

It has been well documented and researched globally that training is vital for the successful adoption of any assistive technology and accelerate the process of cascading any new concept or program.

- Therefore, Saksham will bundle up devices with the requisite training (duration of the training as per the complexity of the technology/device being provided). This will be given by Assistive technology trainers of Saksham.
- Awareness and sensitization workshops will also be organized for the students, parents, staff members and supporting staff.
- Training and orientation sessions will also be arranged for producing accessible content which will involve digitization of notes, preparing assignments and making images and diagrams accessible.
- Employment Oriented workshops, trainings and courses will be provided regularly for guiding the students and help them set their career goals.

2.2.5 Organise Recreational and Sports activities for SBLV

Recreational activities like movie shows of audio described movies will be organized from time to time for students with Blindness and low vision. Adaptive sport activities like Chess competitions with the help of accessible Chess Boards and races using smart cane and tethers can also be organized at the campus.

2.2.6 Awareness and Sensitization activities for Non- disabled students and staff members

Many fun activities can be organized to facilitate social inclusion of PWD. Simple day to day activities with blindfolding the sighted students can be organized which will make them realize the challenges of a student with visual impairment and help to sensitize them.

2.2.7 Making Built Environment Accessible for PWD

Saksham will help the institute make the necessary adaptations with the existing infrastructure for making the built environment accessible for Persons with Disabilities. This includes putting up braille signboards, tactile markings, installing anti- skid and colour reflecting tapes etc..

2.2.8 Provide Need based support to faculty by special educators

Special Educators at Saksham resource Centre can provide support as and when required to the faculty of the college. This would help them to provide necessary support to students with Visual Impairment and low vision in the classroom for their inclusion and education.

2.2.9 Organise financial resources

Saksham will make efforts to arrange funds for carrying out the above- mentioned activities. Funds would be raised through leveraging various schemes of the government of India and through CSR/Individual donations. However, the college would contribute financially wherever it is necessary. The financial commitments related to each of the above-mentioned activities will be decided mutually by the first and the second party.
