

## VARIATION AGREEMENT

**THIS VARIATION AGREEMENT is made BETWEEN:**

(1) The University of Sheffield, a charitable body registered in England and Wales under registration number RC000667, incorporated under Royal Charter and having its main administrative offices at Western Bank, Sheffield, S10 2TN (the "Lead");

and

(2) The University of York, a body incorporated in England and Wales by Royal Charter with registration number RC000679 who principal offices are at Heslington, York, YO10 5DD, United Kingdom ("York")

and

(3) The Janki Devi Memorial College, University of Delhi, an autonomous organization registered in Societies Registration Act XXI of 1860, (Punjab Amendment) Act 1957, As Extended To The Union Territory of Delhi. under registration number S. 1742, incorporated under 1957 and having its main administrative offices at JANKI DEVI MEMORIAL COLLEGE, UNIVERSITY OF DELHI, SIR GANGA RAM HOSPITAL MARG, NEW DELHI -110060 ("Delhi")

each a "Party" and collectively the "Parties".

### BACKGROUND

(A) The Parties entered into a Collaboration Agreement dated 5<sup>th</sup> February 2020 (the "**Original Agreement**") in relation to the project entitled 'Forgotten Food: Culinary Memory, Local Heritage and Lost Agricultural Varieties in India' as attached at Schedule 1.

(B) The Funder has approved a no-cost extension to the Project, as such the Parties wish to amend the Original Agreement on the terms set out in this Variation Agreement.

**IN CONSIDERATION OF** the mutual understandings contained in this Variation Agreement, the Parties agree as follows:

#### **1 Definitions and Interpretation**

1.1 All terms and expressions in this Variation Agreement shall have the same meaning as that given to them in the Original Agreement unless otherwise defined below.

- 1.2 Unless the context otherwise requires, references in the Original Agreement to "this agreement" shall be to the Original Agreement as amended by this Variation Agreement.

**2 Amendments to the Original Agreement**

- 2.1 The parties agree that clause 1 of the Original Agreement shall be deleted and replaced with:

"The Project shall commence on 01 November 2019 and shall continue until 31 October 2022, unless terminated earlier in accordance with this Agreement. The Parties will co-operate to perform the Project. The tasks to be undertaken by each Party for the Project are those allocated to them in the proposal made to Funder for the Project attached at Part 2 of the Schedule to this Agreement (the "Proposal"). The Parties agree to perform such tasks with reasonable skill and care within the scope of their funding."

**3 Continuity**

- 3.1 The provisions of the Original Agreement shall, save as amended in this Variation Agreement, continue in full force and effect, and shall be read and construed as one document with this Variation Agreement.

**4 Third parties**

- 4.1 This Variation Agreement does not create any right enforceable by any person who is not a party to it (a "Third Party") under the Contracts (Rights of Third Parties) Act 1999, but this clause does not affect any right or remedy of a Third Party which exists or is available apart from that Act.
