

## MEMORANDUM OF UNDERSTANDING (MOU)

This Memorandum of Understanding (MOU) is made on 14/06/21 (date) between Janki Devi Memorial College, University of Delhi, Sir Ganga Ram Hospital Marg, New Delhi-110060 (Herein after called the 'First Party')

And

Ladli Foundation Trust, House No 277 Block -9, Dakshin Puri Extension, Dr. Ambedkar Nagar, New Delhi- 110062 (Herein after called the 'Second Party').

And whereas the First Party and the Second Party have agreed to the following terms and conditions of the agreement:

1. This collaboration will involve the Department of Human Development and Family Empowerment, JDMC and Ladli Foundation Trust
2. The aim of the hereby agreement is to provide opportunities to the students to connect their classroom experience to the outside world and to give them the hands on experience. This will not only enhance their various skills (interpersonal, cooperation, decision making and so on) but will also help them in their higher studies and admissions abroad. This agreement is from June 2021 to May 2022.
3. The Deliverables by First Party i.e., Janki Devi Memorial College, University of Delhi are given as follows:
  - a. Jointly hosting the sessions on suitable platforms (virtual or offline depending on the situation).
  - b. Ensuring technical support for smooth conduct of the session
  - c. Documentation of a brief report of sessions/ workshop/ project by the students.
  - d. Active students' participation in terms of time and efforts to the initiatives.
  - e. Jointly promoting the event/ workshop/ seminar on both virtual and physical platforms.
  - f. Working for the community online and in field (depending on the situation).
4. The Deliverables by Second Party i.e. Ladli Foundation Trust are given as follows:
  - a. Facilitating resource persons to conduct talks/ workshops/ seminars/ webinars with the college students on the issues related to education & skill development, Gender and human rights, human trafficking, violence against women, child abuse, child marriage, empowerment of Person with disability and other social issues.
  - b. Generating certificates/ letter of recommendation for participation/ collaboration for internships and community based activities/ initiatives/ projects.
