

### Memorandum of Understanding

**Date: 28th February 2018**

This Memorandum of Understanding (hereinafter referred to as the "MoU") is between Triedge Solutions Private Limited (hereinafter referred to as "Triedge" or the "First Party") Corporate Office at 403, 4<sup>th</sup> floor, Prem Sadan, 11 Rajendra Place, New Delhi 110008 and Janki Devi Memorial College, University of Delhi (hereinafter referred to as "College" or the "Second Party") wherein the College has invited Triedge to organize an Online Internship Fair for its students on its website [www.triedge.in](http://www.triedge.in) and Triedge has agreed to organize an Online Internship Fair.

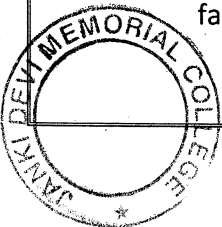
As part of this MoU, Triedge shall organize the Triedge Online Internship Fair for Women (hereinafter referred to as the "Fair"), wherein all women colleges under the aegis of Delhi University shall be invited to participate in the Fair and the colleges agreeing to participate shall be designated as Fair "CHAMPIONS" or any other similar title. The College has agreed to participate in the aforementioned Fair.

It has been agreed between the parties that women students of all colleges and institutions will be allowed to participate in the Fair. It has also been agreed between the parties that the Fair will be scheduled for a period of 10 days in March 2018. The Fair may be extended by the First Party for a further period of 10 days if in its opinion the extension would increase the number of students being selected for Internships.

As part of this MoU, Triedge shall provide the following services:

1. Create a webpage for the Fair and host it on [www.triedge.in](http://www.triedge.in) for the duration of the Fair to disseminate information and to enable participating companies and students to post positions and apply for those positions respectively.
2. Create a webpage for the College and host it on [www.triedge.in](http://www.triedge.in) for the duration of the Fair.
3. Invite Companies to participate in the Fair and post Internship positions for students on [www.triedge.in](http://www.triedge.in) so that the students can apply for the positions.
4. Invite and arrange, on best efforts basis, media partners, corporate partners and event collaborators to contribute towards the publicity and success of the Fair. The Second Party agrees that the First Party will have the sole discretion to identify, appoint and finalize the terms of engagement with such third parties.

Triedge has created [www.triedge.in](http://www.triedge.in) to contribute towards the success of aspiring professionals and it therefore supports the initiatives being taken by The Placement Cell, faculty and students of the College. It shall therefore arrange and/or incur the cost of



organizing the Fair and the cost for providing the aforementioned services. Triage shall not charge any fees to the College for the aforementioned services and the College and its students will not be required to pay any fees, charges or costs to Triage for the aforementioned Services.

As part of this MoU, the College will provide the following support for the organization and success of the Fair:

1. Provide the following information to Triage so that the same can be displayed on the webpages created for the Fair and on [www.triedge.in](http://www.triedge.in) :
  - a. a "Message" from the Principal, Placement Convenor and/ Or Placement Cell Members,
  - b. a brief write-up about the College,
  - c. a Photograph and Logo of the College
2. Publicize and market the Fair through offline & online channels to enable maximum participation from students of the College and other women students.
3. To encourage students to apply for positions posted by participating companies
4. To encourage the Placement Cell and student volunteers to work in collaboration with Triage so as to expand the list of Companies participating in the Fair.

The College appreciates the services being provided by Triage and has agreed to participate in the Fair and provide the aforementioned support, free of any cost.

Neither party will pay any fees to the other party for the services mentioned above.

Neither Party provides any guarantees, warranties or assurances to the other party or to the participating companies or any other person for the success of the Fair. The College does not provide any guarantees or assurances to Triage on the number of students who will participate in the Fair. Nor does Triage provide any guarantees or assurances to the College on the number of students who will get Internship offers through the Fair. Both parties agree that the prerogative to make an offer to hire interns belongs solely to the participating companies and the prerogative to accept such an offer belongs solely to the applicant. Triage does not take any responsibility for the decisions, actions or inactions, present or future, of the participating companies and the students.
