Noteworthy Points

For general outcomes

1. In all the seven cases, it can be observed that the majority (70-80%) of students either agree or strongly agree with the statements which reflects that the general outcomes of the program B.Com (H) have been achieved successfully.
2. Very less no. of students (around 10%) feel neutral about the achievement of program. In only one case, the percentage of students is feeling neutral is relatively high (more than 24%) – ‘The program has made me capable of comprehending international frameworks keeping in view research aspects in consideration’, which provides a domain for improvement.
3. In most of the cases, there is not much difference between the percentage of students who agree with the given statements and those who agree strongly.

For program-specific outcomes

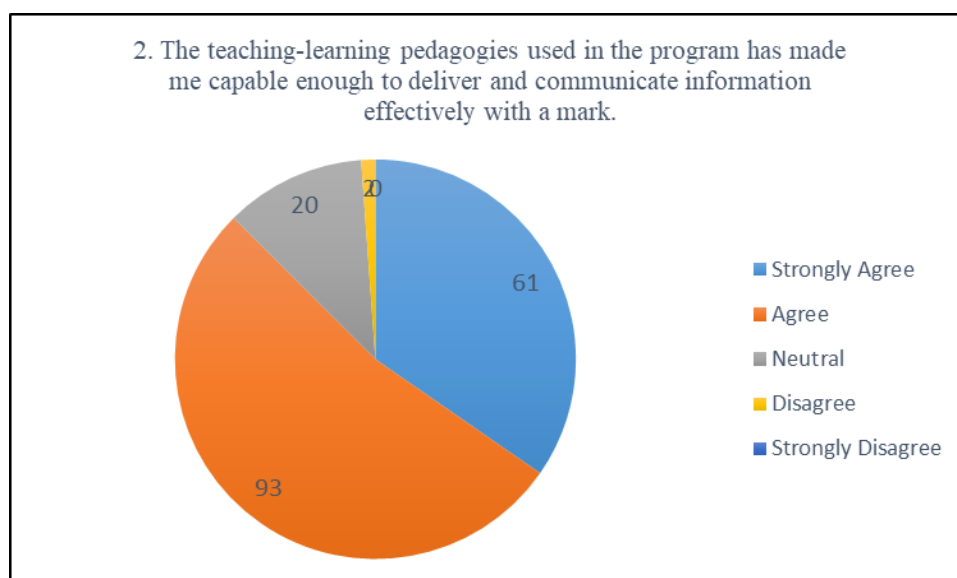
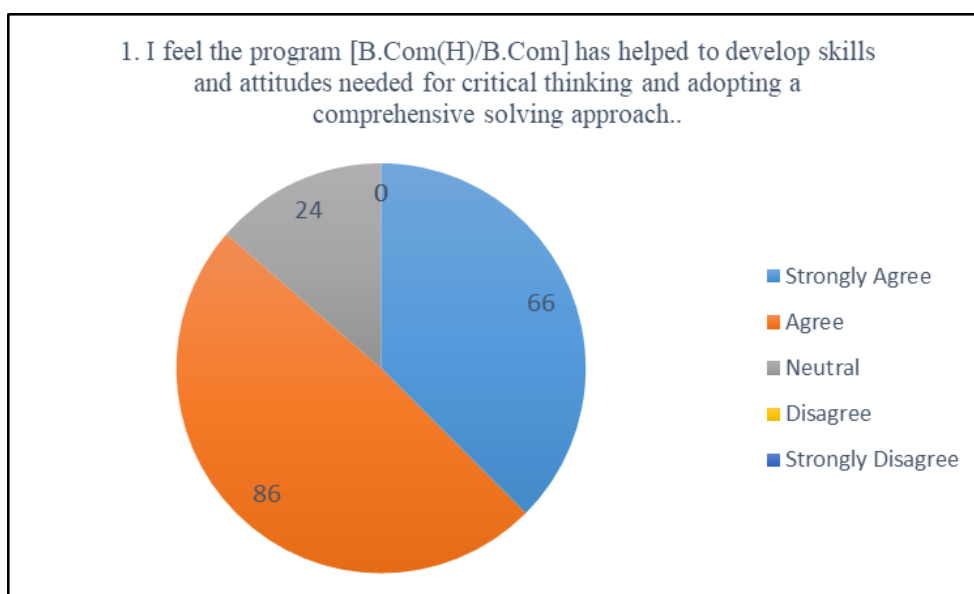
1. In all the seven cases, it can be observed that the majority (around 80%) of students either agree or strongly agree with the statements which reflects that the program-specific outcomes of the program B.Com (H) have been achieved successfully.
2. Very less no. of students (less than 12%) feel neutral about the achievement of program with the exception of the case where the percentage of students feeling neutral is relatively high (more than 14%) – ‘The program has inculcated attitudes and character that will help me to evolve into sensitive and technologically sound future business leaders rather than managers enhancing employability options’, which provides a domain for improvement.
3. In most of the cases, there is a significant difference between the percentage of students who agree with the given statements and those who agree strongly, as compared to the general outcomes.

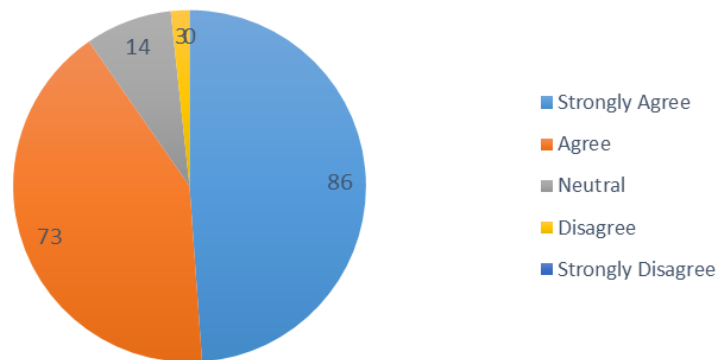
